A G R E E M E N T.

THIS AGREEMENT, Made and entered into this 18th, day of August A. D. 1909, by and between E. C. Ryan, of Tulsa, Oklahoma, party of the first part, and Henry N. Greis, of Chanute, Kansas, and Irvan L. Tilden, of Muskogee, Oklahoma, parties of the second part:

WITNESSETH: THAT WHEREAS, the party of the first part is the owner of a certain oil and gas lease on premises situated in Tulsa County, Oklahoma, to-wit:

1. a certain oil and gas lease given by George Tucker, Guardian of William Tucker, a minor, on the 28th, day of July A. D. 1909, said lease being approved by the County Court of said County on the 28th, day of July A. D. 1909, and being recorded at Book --- page---- in the Office of the Register of Deeds in and for said county and covering the following described property, to-wit:

The Southeast Quarter ($\frac{1}{4}$) of the Southeast Quarter ($\frac{1}{4}$) of Section Five (5) Township Twenty (20) North Range Thirteen (13) East; and Northwest Quarter ($\frac{1}{4}$) of the Northwest Quarter ($\frac{1}{4}$) of Section Nine (9), Township Twenty (20) North, Range Thirteen (13) East, all in Tulsa County, Oklahoma.

2. A certain oil and gas lease given by George Tucker as Guardian of George H. Tucker, minor, on the 28th, day of July A. D. 1909, said lease being approved by the County Court for said County on the 28th, day of July A. D. 1909, and being recorded in the office of the Register of Deeds in and for said County at Book ---- Page---- and covering the following property to-wit:

The South Half ($\frac{1}{2}$) of the Southwest Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of Section Four (4), Township Twenty (20) North, Range Thirteen (13) East, and the Southwest Quarter ($\frac{1}{4}$) of the Northwest Quarter ($\frac{1}{4}$) of Section Nine (9), Township Twenty (20) North Range Thirteen (13) East, all in Tulsa County, Oklahoma.

And whereas it is desired by the parties hereto ~~to~~ enter into a contract whereby the second parties shall drill ~~one~~ well on said premises, and become thereby the owner of the interest therein.

IT IS THEREFORE AGREED by and between said parties as follows:

Second parties agree to, at their own expense, drill a well for oil or gas on some one of the tracts described in the above named leases said well to be drilled to the second sand, a depth of Fifteen Hundred (1500) feet, more or less, to case and tube the
