DEED OF POSSESSION.

WITNESSETH: That . for and in consideration of the sum of Five Hundred and Nineteen (\$519.00) Dollars, in hand paid, by the said party of the second part to the said party of the first part, the receipt of which is hereby acknowledged.

The said party of the first part does hereby grant, bargain, sell and convey unto the said party of the second part, all his right, title and interest in and to the possession and occupancy of the following described tracts or parcels of land, situated in the town of Tulsa, I. T., to-wit:

A certain tract 150 K 150 ft. bounded as follows: Commencing at the Southwest corner (SW) of Broadway and Second Street, said Second Street running East & West from Hogans Stock & Livery barn to Robt. Fry's residence, now occupied by Dr. J. S. McAllister) and running East One Hundred and Fifty (150 ft.) feet, Thence North One Hundred and fifty (150 ft.) feet; Thence West One Hundred and Fifty (150 ft.) feet; Thence South One Hundred & Fifty feet (150 ft.) to place of beginning.

The above described tract of land being the West 1 of the "Hefflefinger Place", and later as the "Billy Mann Place".

The said tract or parcel of land above described has been subrogated from the public domain of the Creek Nation and now occupied by said party of the first part, and free from all incumbrance.

TO HAVE AND TO HOLD said premises to the said party of the second part, his heirs and assigns forever.
