It is further expressly agreed that this lease is made with full knowledge of the fact that under the regulations prescribed by the Secretary of the Interior governing the leasing of lands in the **Here of the** Nation, Indian Territory, lessees are prohibiled from being directly or indirectly interested in leases, in their own names or in the names of other persons, or as owners or holders of stock in corpor-ations, or as members of associations, covering an aggregate of more than 4,500 acressed land in the Chordaw, Chickasaw, Cherokee, Creek, and Semirable Nations, that the said prohibition is made a part and condition of this lesse, and that the Secretary of the Interior reserves the right to marel leases at any time during the period for which they are to run, after notice as herein mentioned, when by Satisfied that the terms of the lease or of the regulations heretofore or hereafter prescribed have been violated in any particular, and further agree not to transfer, assign, or sublet, by working or drilling contract or otherwise, or allow the use of the land leased, or any oll or gas in or under it, with-out first oblaining the consent of the Secretary of the Interior, and that any violation of the lease or of the regulations heretofore or hereafter prescribed by the Secretary of the Interior, respecting oil and gas leases in the secret of notice, in the discretion of the Secretary of the Interior, whose declaration of cancellation and gas leases in the leaser shall then be entitled to immediate possession of the land.
