This Indenture, Made this 2nd day of September, A. D. 1909 between C. O. Winterringer and Grace E. Winterringer his wife of Tulsa County, in the State of Oklahoma, of the first part, and William W. Tulsa County, Oklahoma of the second part.

WITNESSETH, The said parties of the first part, in consideration of the sum of Twenty seven and no DOLLARS, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell and convey unto the said party of the second part, his heirs and assigns, all of the following described real estate, situated in the County of

Tulsa and State of Oklahoma, to-wit: The north ninety feet (90) of Lot ten (10) and the south ten feet (10) of Lot eleven (11) in Block nineteen (19) of north Tulsa as shown by the official plat of the said addition

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining forever.

And said C. O. Winterringer, Grace E. Winterringer his wife for their heirs, executors or administrators, do hereby covenant, promise and agree to and with said party of the second part, that at the delivery of these presents they are lawfully seized in their own right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above granted and described premises with the appurtenances; that the same are free, clear, discharged and unincumbered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what nature and kind soever; the said party of the second part to assume a certain mortgage of \$2,500 that is now against the said property and that they will warrant and forever defend the title to the same unto said party of the second part his heirs and assigns, against said party of the first part their heirs and all and every person whomsoever, lawfully claiming or to claim the same.
