WITNESSETH, The said party of the first part, in consideration of the sum of One Thousand
and no/od *(88100)* and DOLLARS,

the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said party of the second part, his heirs and assigns, all of the following described real estate, situated in the County of Tulsa
and State of Oklahoma, to wit:

Lot two (2) in Block Six (6) in the
Bansberry addition to the City of Tulsa
Oklahoma, according to the recorded plat
thereof.

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances
thereunto belonging or in any wise appertaining forever.

for themselves, executors or administrators, do here covenant, promise and agree to and with said party of the second part, that at the delivery of these presents they are lawfully seized in their own right of an absolute

charges, judgments, taxes, assessments and incumbrances, of what nature and kind soever;

claim the same.
