This Indenture, Made this 25th day of October A. D. 1909
between *Annie M. Varnest*

Tulsa Oklahoma Tulsa
County, in the State of Oklahoma, of the first part, and *P. H. Varnest*

WITNESSETH, The said part 1st of the first part, in consideration of the sum of *One Dollar*
(\$1.00) and other valuable considerations *to wit:*
the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said part 2^d of
the second part, *his* heirs and assigns, all of the following described real estate, situated in the County of
property herein described *located in the County of Tulsa*
and State of Oklahoma, to-wit:

all her right and title in and to the oil gas coal and other minerals lying
being in and under the following described real estate located in
Tulsa County to-wit: Southwest quarter S.W. 1/4 of section Twenty
four (24), township nineteen (19) north Range Thirteen (13)
east. Together with the rents royalties and profits that may
be derived from the sale of the oil gas coal or other
minerals located as aforesaid and this instrument shall be
full warranty for the payment to the said P. H. Varnest of any proceeds
from the sale of said minerals including the proceeds that may become
due me from lease given by me on the 4th day of October 1907 to the
March Oil Company on the above described property.

To have and to hold the same, together with all and singular the franchises, appurtenances and appurtenances
thereunto belonging or in any wise appertaining forever.

And said *Annie M. Varnest*
for *her* heirs, executors or administrators, do here covenant, promise and agree to and with said part 2^d of the second
part, that at the delivery of these presents *she is* lawfully seized in *her* own right of an absolute

with the appurtenances; that the same are free, clear, discharged and unincumbered of and from all former grants, titles,
charges, judgments, taxes, assessments and incumbrances, of what nature and kind soever;

and that *she* will warrant and forever defend the title to the same unto said part 2^d of the second part *his* heirs and
assigns, against said part 1st of the first part *her* heirs and all and every person whomsoever, lawfully claiming or to
claim the same.
