the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said party of the second part, heirs and assigns, all of the following described real estate, situated in the County of

Tulsa and State of Oklahoma, to-wit:Lots three (3) four (4) five (5) and six (6) in Block three (3) in said lot, addition to the City of Tulsa County of Tulsa State of Oklahoma.

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in any wise appertaining forever.

Gillepie for his heirs, executors or administrators, do here covenant, promise and agree to and with said party of the second part, that at the delivery of these presents that he is lawfully seized in his own right of an absolute and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above granted and described premises with the appurtenances; that the same are free, clear, discharged and unencumbered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what nature and kind soever;and that he will warrant and forever defend the title to the same unto said party of the second part, heirs and assigns, against said party of the first part his their heirs and all and every person whomsoever, lawfully claiming or to claim the same.
