WITNESSETH, That said party of the first part, in consideration of the sum of  
Twenty Four Hundred and DOLLARS,  
the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said party of the second part, their heirs and assigns, all of the following described real estate, situated in the County of Tulsa  
and State of Oklahoma, to wit:  
Lot ten (10) Block one (1) in the Elm Addition to the City of Tulsa Oklahoma  
according to the record plat thereof.

The grantors assumed certain mortgage indebtedness as part of the purchase price, the said mortgage was given to the Farm and Home Savings and Loan Association, of Nevada, Missouri.

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in any wise appertaining forever.

And said grantors, for themselves and for their heirs, executors or administrators, do here covenant, promise and agree to and with said party of the second part, that at the delivery of these presents they are lawfully seized in their own right of an absolute and indefeasible estate of inheritance, in fee simple, of, to and in all and singular the above granted and described premises with the appurtenances; that the same are free, clear, discharged and unencumbered of and from all former grants, titles, charges, judgments, taxes, assessments and incumbrances, of what nature and kind soever, except aforesaid mortgage.
