WITNESSETH, The said part 1 of the first part, in consideration of the sum of Eighteen Hundred
and 25 DOLLARS,
the receipt of which is hereby acknowledged, do hereby these presents grant, bargain, sell and convey unto the said part 1 of
the second part, his heirs and assigns, all of the following described real estate, situated in the County of Tulsa
and State of Oklahoma, to-wit:

all of Lots eight (8) eight (8) nine (9)
and ten (10) in Block three (3) of Drew
addition to the city of Tulsa Oklahoma according
to the plat of said addition on file in the
office of the Register of deeds of Tulsa County
on which plat said addition is described
as Campbell addition, sometimes known as
Drew addition to Tulsa, Tulsa County
Oklahoma

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances
thereunto belonging or in any wise appertaining forever.

And said Emily M. Campbell for herself her
heirs, executors or administrators, do hereby covenant, promise and agree to and with said part 1 of the second
part, that at the delivery of these presents she is lawfully seized in her own right of an absolute
and indefeasible estate of inheritance, in fee simple, of, in and to all and singular the above granted and described premises
with the appurtenances; that the same are free, clear, discharged and unincumbered of and from all former grants, titles,
charges, judgments, taxes, assessments and incumbrances, of what nature and kind soever;

and that she will warrant and forever defend the title to the same unto said part 1 of the second part his heirs and
assigns, against said part 1 of the first part her heirs and all and every person whosoever, lawfully claiming or to
claim the same.
