WARRANTY DEED. -

KNOW ALL MEN BY THESE PRESENTS, That Julia M. Boling and James M. Boling her Husband of Claremore, Rogers County, Oklahoma, and H. M. Wilson and Elesta Wilson their wife of Tulsa, Tulsa County, State of Oklahoma on a day in the month of May, A.D. 1910, part 9
of the first part, in consideration of the sum of One Dollar as new love and affection

(S.) in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell and convey unto Rachel C. Brady of Tulsa, Tulsa County, State of Oklahoma on a part of the second part, the following-described real property and premises, situate in Tulsa County, State of Oklahoma, to-wit:
Part of lot 5 Block 21 North Tulsa, described as follows: Beginning at the NE corner of said lot; thence N. 72.3 feet along the Berlin St Line; thence in a westerly direction 140 feet to Alley 12.6 ft. to Creek Nation line; thence S. along Alley line 12.6 ft. to Creek Nation line, thence East on said Creek Nation line 153.3 ft. to beginning. Also that part of lot 4 Block 31 North Tulsa described as follows: Beginning at the SE corner of said lot; thence N. 41.1 ft. along the alley; thence West 10 ft. to the Creek Nation line; thence East along said Creek Nation line 10.8 ft. to place of beginning. Also that part of lot 1 Block 7 City of Tulsa, described as follows: Beginning at the NW corner of said lot; thence S. 14.7 ft. thence in a westerly direction 140 ft. to Alley 1; thence in a Northerly direction 79.4 ft. to NW corner of said lot; thence back along the line of said lot, same being the Creek Nation line 153.3 ft. to place of beginning.
