

## MORTGAGE OF REAL ESTATE.

This Indenture, Made this Twentieth day of October 1917, by and between  
Martin H. Tierney and his wife Mary Agnes Tierney  
 of Tulsa County, in the State of Oklahoma, of the first part, and

of the second part:

Witnesseth: That the said parties of the first part, for and consideration of the sum of \_\_\_\_\_ DOLLARS, to them in hand paid, by the party of the second part, the receipt whereof is hereby acknowledged, have Granted; Bargained, Sold, Conveyed, and do by these presents Grant, Bargain, Sell, Convey and Confirm unto the said party of the second part, and to his heirs, executors, administrators or assigns, forever, all the following described tract of land, situated in \_\_\_\_\_ in Tulsa County, State of Oklahoma, to-wit:

To Have and to Hold the Same, with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and all rights of homestead exemption unto the said party of the second part, and to his heirs and assigns, forever.

This mortgage is given as security for the performance of the covenants herein, and the payment to \_\_\_\_\_ the party of the second part, the principal sum of \_\_\_\_\_ Dollars, due to said second party for an actual loan of the said amount on the \_\_\_\_\_ day of \_\_\_\_\_ 19\_\_\_\_, according to the terms and conditions of \_\_\_\_\_ principal note in the amount of \_\_\_\_\_ Dollars, dated the \_\_\_\_\_ day of \_\_\_\_\_ 19\_\_\_\_, and \_\_\_\_\_ accompanying coupon interest notes, each in the sum of \_\_\_\_\_ Dollars, and bearing the same date, made and executed by the parties of the first part.

Second: Said parties of the first part hereby covenant and agree to pay all taxes and assessments of whatsoever character on said lands, when the same becomes due, and to keep the buildings upon the mortgaged premises insured in some reliable fire insurance company, approved by the party of the second part, for the sum of \_\_\_\_\_ (\$ \_\_\_\_\_) Dollars, and to assign the policies to said party of the second part, as his interest may appear, and deliver said policies and renewals to said party of the second part, to be held by him until this mortgage is fully paid, and the said parties of the first part assume all responsibility of proof and care and expense of collecting such insurance if loss occurs. In the event of default by the party of the first part in any payment or payments of taxes, assessments of any kind, or of insurance premiums, party of second part may pay same and such sums so paid shall thereafter draw interest at the rate of 8 per cent. per annum.

Third: It is further expressly agreed by and between the parties hereto, that if any default be made in the payment of any part of either said principal or interest notes, when the same become due, or in case of default in the payment of any installment of taxes or assessments upon said premises, or the premium for said fire insurance, when the same become due, or in case of the breach of any covenant or condition herein contained, the whole of said principal sum herein named, and the interest thereon, shall immediately become due and payable, at the option of the second party, and this mortgage may be immediately foreclosed.

Now if said parties of the first part shall well and truly pay to the said party of the second part, his heirs, executors, assigns, or administrators, the sum of money hereinbefore recited, and all other amounts which may be paid out by said second party or assigns, under the provisions of this mortgage, and all other indebtedness which may be due said party or assigns, at the times herein stipulated then this conveyance shall be null and void, otherwise to remain in full force and effect. And in case of any default in the payment of said indebtedness, or failure of said first party to fulfill any of the stipulations and agreements herein contained, said party of the second part, his heirs or assigns, agents or attorneys, are hereby authorized and empowered to declare the whole indebtedness hereby secured at once due and payable, to take charge of said property on demand without process of law, and proceed with the foreclosure of this instrument as provided by law.
