

NOTE OR OBLIGATION.

Nevada, Missouri, *Mo July 20th* 19 *10*

FOR VALUE RECEIVED *we* promise to pay to the order of the FARM AND HOME SAVINGS AND LOAN ASSOCIATION OF MISSOURI, the following sums of money, viz: The sum of *Twelve* Dollars, the same being the monthly dues on the *One* share of the capital stock of said Association, represented and evidenced by the certificate thereof, numbered *2586* this day pledged by *us* to said Association to secure a loan of *One thousand* Dollars, and the sum of *Five and 50/100* Dollars, the same being the interest due monthly upon said sum so borrowed by *us*, and the sum of *One and 50/100* Dollars, the same being the premium due monthly upon said sum so borrowed. And *we* promise to pay to said Association at its Home Office at Nevada, Missouri, all of said sums of money amounting in the aggregate to *Twenty* Dollars, on the 20th day of each and every month, and continue such monthly payments until the dues, payments on stock, together with the earnings and profits credited thereon, shall make said certificate of stock equal to the par or face value of said certificate of stock, and said certificate of stock is estimated to mature and reach par value in *7 1/2* months from date thereof.

And *we* further agree, in case of default in the payment of said sums of money, or any part thereof, monthly as aforesaid, to pay all fines and penalties assessed on account thereof, in accordance with the rules and regulations of said Association, and if, in case of default, the stock pledged and the security given to secure said monthly payments shall, upon the sale thereof, be insufficient to pay said Association any balance which may be due and owing on said loan, *we* promise and agree to fully pay and discharge the same. The payment of said monthly sum, aggregating *twenty* Dollars, each and every consecutive month hereafter until the maturity of said stock, and the payment of all fines, penalties, advances, liens and other charges shall entitle all of said certificate of stock to redemption by said Association at the accredited value thereof, and the said share of stock so taken and redeemed shall be taken by said Association in full satisfaction of this Obligation and Deed of Trust or Mortgage to secure the same.

This obligation may be paid off at any time upon giving thirty days' written Notice to the Home Office of the Association at Nevada, Missouri, in which event this Note or Obligation may be credited on such repayment of loan with the withdrawal value of the stock carried with the same.

NOW, THEREFORE, If said part *us* of the first part shall pay the several sums of money mentioned in said note or obligation, including all dues, interest and premium, when they shall be or become due and payable, as aforesaid, and shall faithfully perform all of the said other agreements, then these presents shall be void; otherwise, the same shall be and remain in full force and effect, and this mortgage may be immediately foreclosed and enforced for the unpaid amount of the principal of said note, the unpaid interest and premium, and the expenditures hereinbefore named, made by the said party of the second part, to pay said taxes, assessments and insurance, and to protect the title to said premises, together with the charges as provided by the By-Laws of said Association, for the non-payment of said interest, premiums, expenditures, and the payment of mortgages before their maturity, and *One hundred* Dollars attorney's fee for instituting suit upon this Mortgage; also for foreclosing the same; all of which shall be a lien upon said premises and secured by this mortgage, and included in any decree of foreclosure rendered thereon, and all rents collected by said party of the second part shall be applied on the payment of said debt. And the said part *us* of the first part, for said consideration, do hereby expressly waive an appraisalment of said real estate and all benefits of the homestead exemption and stay laws of the State of Oklahoma.

IT IS UNDERSTOOD AND AGREED, by and between the parties hereto that this entire contract, and each and every part thereof, is made and entered into in accordance with the By-Laws of the FARM AND HOME SAVINGS AND LOAN ASSOCIATION OF MISSOURI, and the laws of the State of Missouri, and in construing this contract the By-Laws of said Association and the Laws of the State of Missouri are to govern.
