


# GENERAL WARRANTY DEED.



This Indenture, Made and entered into this 8th day of August, one thousand nine hundred and six, by and between Silas B. Childers, mixed blood Creek Indian and Okla. Land Com. Genl. of Coweta, Ind. Ter., part y of the first part, and of Muskogee, Ind. Ter. part y of the second part,

WITNESSETH: That the said party of the first part, for and in consideration of the sum of One dollar & other Dollars, in hand paid, the receipt of which is hereby acknowledged, do as hereby grant, bargain, sell, convey and confirm unto said party of the second part the following described real estate and premises situated in the Creek Nation, and within the limits of the Indian Territory to-wit:

All his undivided interest in the allotment of his deceased brother Paul Childers said allotment being Northeast quarter of Section Three (3) and all his undivided interest in the allotment of his deceased brother Paul Childers said allotment being Southeast quarter of Section Three (3) both in Township Twentieth (20) North Range Fourteen (14) East.

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Mary A. Childers, wife of the said Silas B. Childers, for and in consideration of the said sum of money, do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said party of the second part, its heirs, executors, administrators and assigns forever.
