

GENERAL WARRANTY DEED.

This Indenture, Made and entered into this 25th day of March, one thousand nine hundred and seven, by and between George Fields, a single man and Thomas J. Meagher and Chas. F. Runyon of Muskogee, I. T., part 7 of the first part, and of Muskogee, I. T. parties of the second part,

WITNESSETH: That the said part 7 of the first part, for and in consideration of the sum of One Thousand Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said parties of the second part the following described real estate and premises situated in the Creek Nation, and within the limits of the Indian Territory to-wit:

The north one half of South West one quarter of Section Six, Township Eighteen North Range Thirteen East and East one half of North East quarter of Section Eight, Township Eighteen North Range Thirteen East

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, George Fields, wife the said Thomas J. Meagher and Chas. F. Runyon, for and in consideration of the said sum of money do hereby release and relinquish unto the said part 7 of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said parties of the second part their heirs, executors, administrators and assigns forever.
