This Indenture, Made and entered into this Fifth day of March, one thousand nine hundred and seven, by and between A. S. Perryman and J. E. Mason of Gatesville, I. T., part y of the first part, and of Little Rock Ark part y of the second part,

WITNESSETH: That the said part y of the first part, for and in consideration of the sum of One Hundred and Fifty (\$150) Dollars, in hand paid, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell, convey and confirm unto said part y of the second part the following described real estate and premises situated in the Creek Nation, and within the limits of the Indian Territory to-wit: The Northeast Quarter of the Southeast Quarter of the Northeast Quarter of Section Thirteen (13), Township Nineteen (19) North, Range Fourteen (14) East, being ten acres more or less

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, J. E. Mason, wife of the said A. S. Perryman, for and in consideration of the said sum of money do hereby release and relinquish unto the said part y of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said part y of the second part his heirs, executors, administrators and assigns forever.
