

# GENERAL WARRANTY DEED.

This Indenture, Made and entered into this 11th day of March, one thousand nine hundred and seven, by and between J.E. Mason (a single man) and J.M. Outchfield of Little Rock Ark, part y of the first part, and

 WITNESSETH: That the said party of the first part, for and in consideration of the sum of Two Hundred Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part of the second part the following described real estate and premises situated in the Creek Nation, and within the limits of the Indian Territory to-wit:

The North East Quarter of the South East Quarter of the North East Quarter of Section Thirteen (13) Township Nineteen (19) North Range Fourteen (14) East, being Ten acres more or less.

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, J.E. Mason, wife the said J.M. Outchfield, for and in consideration of the said sum of money do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said party of the second part his heirs, executors, administrators and assigns forever.
