**GENERAL WARRANTY DEED.**

This Indenture, Made and entered into this 12 day of April, one thousand nine hundred and seven, by and between S. A. Bryan and his wife Ula P. Bryan of Vara Ind. Ter. parties of the first part, and C. B. Brown of Vara Ind. Ter. part of the second part,

WITNESSETH: That the said parties of the first part, for and in consideration of the sum of Two Hundred no/100 Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part of the second part the following described real estate and premises situated in Cherokee Nation, and within the limits of the Indian Territory to-wit: The south one half (1/2) of Lot one (1) in block six (6) of Vara Ind. Ter., except the claims of the Cherokee Government

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Ula P. Bryan, wife the said S. A. Bryan, for and in consideration of the said sum of money do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said part of the second part his heirs, executors, administrators and assigns forever.
