WITNESSETH: That the said part 7 of the first part, for and in consideration of the sum of (\$200.00) Two Hundred Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part 7 of the second part the following described real estate and premises situated in the Creek Nation, and within the limits of the Indian Territory to-wit: all of Lot Number (1) seven in Block Number (143) Fort Totten in the original town of Red Fork, I. T. as shown by the government plat thereof.

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Mary Hughes, wife the said C. N. Jones, for and in consideration of the said sum of money do hereby release and relinquish unto the said part 7 of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said part 7 of the second part his heirs, executors, administrators and assigns forever.
