WITNESSETH: That the said party of the first part, for and in consideration of the sum of 1000 Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part 1st of the second part the following described real estate and premises situated in Creek Nation, and within the limits of the Indian Territory to-wit:

The north east 1/4 quarter of the south east 1/4 quarter of Section 43, Township 18 North, Range 14, fourteenth east

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Annie Barnett, wife the said

Annie Barnett, for and in consideration of the said sum of money do hereby release and relinquish unto the said part 1st of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said part 1st of the second part its heirs, executors, administrators and assigns forever.
