GENERAL WARRANTY DEED.

This Indenture, Made and entered into this twenty eighth day of December, one thousand nine hundred and six by and between Amzy W. Schooley and Joe Hester Schooley his wife of Collinsville, Indian Territory of the first part, and B. D. Brookshier of Kingfisher County, Ok. part of the second part,

WITNESSETH: That the said parties of the first part, for and in consideration of the sum of One no 100 Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part of the second part the following described real estate and premises situated in Cherokee Nation, and within the limits of the Indian Territory to-wit:

All 7 lots sixteen (16) and seventeen (17) in Block numbered Sixty (60) in the town of Collinsville, Indian Territory, as per the United States Government survey and plat of said town.

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Joe Hester Schooley, wife the said Amzy W. Schooley, for and in consideration of the said sum of money do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said part of the second part his heirs, executors, administrators and assigns forever.
