This Indenture, Made and entered into this 15<sup>th</sup> day of May one thousand nine hundred and seven by and between Joe Childers a single man and Harry L. Harris of Broken Arrow, part of the first part, and part of the second part,

WITNESSETH: That the said part of the first part, for and in consideration of the sum of Five Hundred Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part of the second part the following described real estate and premises situated in the Western Nation, and within the limits of the Indian Territory to-wit: The south-west quarter (1/4) of the south-east quarter (1/4) of Section thirty-four (34) Township eighteen (18) North Range fourteen (14) East

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Joe Childers, wife of the said Joe Childers, for and in consideration of the said sum of money do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said part of the second part his heirs, executors, administrators and assigns forever.
