This Indenture, Made and entered into this 12 day of July, one thousand nine hundred and seven, by and between Daniel Company and a single man of Boydston, part of the first part, and W. D. Cornelius of muskegee part of the second part,

WITNESSETH: That the said part of the first part, for and in consideration of the sum of One Thousand Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part of the second part the following described real estate and premises situated in The Creek Nation, and within the limits of the Indian Territory to-wit:

The north half of the south west quarter of section thirty (32) and the south east of E quarter of the north west (NW) quarter of section thirty (32) all in township twelve (12) N. Range twelve (12) E. containing 120 acres more or less

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, W. D. Cornelius, wife the said W. D. Cornelius, for and in consideration of the said sum of money do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said part of the second part his heirs, executors, administrators and assigns forever.
