WITNESSETH: That the said parties of the first part, for and in consideration of the sum of seven
Hundred Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part 4 of the second part the following described real estate and premises situated in Creek Nation, and within the limits of the Indian Territory to-wit:

The Northeast Quarter of the Northwest Quarter
of Section Twelve (12), Township Eighteen (18), North
Range Fourteen (14) East, containing Forty (40) acres
more or less.

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Niecy Johnson, wife the said Isaac Johnson, for and in consideration of the said sum of money do hereby re-

lease and relinquish unto the said part 4 of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said part 4 of the second part his heirs, executors, administrators and assigns forever.
