This Indenture, Made and entered into this eighth day of October, one thousand nine hundred and ten, by and between Ethel Etchen, and David Etchen her husband and Lewis J. Owen of Collinsville, Mo., parties of the first part, and of Indian Territory part of the second part,

WITNESSETH: That the said parties of the first part, for and in consideration of the sum of one hundred Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said party of the second part the following described real estate and premises situated in Indian Territory Nation, and within the limits of the Indian Territory to-wit:

All of Lots numbered One (1), Two (2), and Three (3) in Block numbered One (1) in Block addition to the town of Stearns, Indian Territory, according to the recorded plat thereof.

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, David Etchen husband, wife the said Ethel Etchen, for and in consideration of the said sum of money do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said party of the second part his heirs, executors, administrators and assigns forever.
