

# GENERAL WARRANTY DEED.

This Indenture, Made and entered into this 18 day of July, one thousand nine hundred and six, by and between W. A. Watson & Viola Watson & Mollie Jefferson Charlie Lewis & Lilla Lewis and Maria Williams and Kaiser Jameson of the first part, and Harry L. Stevens of the second part,

WITNESSETH: That the said parties of the first part, for and in consideration of the sum of fifty Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said party of the second part the following described real estate and premises situated in the United States Nation, and within the limits of the Indian Territory to-wit: all of the northeast 1/4 of the south west quarter (1/4) of the south east quarter (1/4) of the south west quarter (1/4) of section fourteen (14), Township sixteen (16) North, Range twelve (12) East, also the east half (1/2) of the south west quarter (1/4) of the south west quarter (1/4) and the west half of the south east quarter (1/4) of the south west quarter (1/4) of section twenty-two (22), Township sixteen (16) North, Range twelve (12) East, also the North East quarter (1/4) of the Northwest quarter (1/4) and the east twenty (20) acres of Lot one (1) and North west Nine and 5/16 acres of Lot one (1) Section nineteen (19), Township sixteen (16) North, Range thirteen (13) East of the Indian (Bust) and Meridian in the Indian Territory, being all the allotment of Charles Austin, deceased.

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Viola Watson wife of the said W. A. Watson and Lilla Lewis, wife of the said Charlie Lewis, for and in consideration of the said sum of money do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said party of the second part his heirs, executors, administrators and assigns forever.
