

## GENERAL WARRANTY DEED.

This Indenture, Made and entered into this 27th day of October, one thousand nine hundred and six, by and between Alonzo Ward and Mahala Ward his wife of Lawson, parties of the first part, and J. S. Robinson and John W. Mitchell of Idaho, parties of the second part,

WITNESSETH: That the said parties of the first part, for and in consideration of the sum of three hundred and fifty Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said parties of the second part the following described real estate and premises situated in the Cherokee Nation, and within the limits of the Indian Territory to-wit:

N.E. 1/4 of the N.W. 1/4 of Section Thirty Three (33) Township Twenty one (21) Range Thirteen (13)

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Mahala Ward, wife of the said Alonzo Ward,

for and in consideration of the said sum of money do hereby release and relinquish unto the said parties of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said parties of the second part their heirs, executors, administrators and assigns forever.
