This Indenture, Made and entered into this 15th day of August, one thousand nine hundred and six, by and between Daniel Childers, a mixed blood Creek Indian and Oklahoma Land Company of Broken Arrow, Ind. Terr., part of the first part, and of Muskogee, Ind. part of the second part,

WITNESSETH: That the said party of the first part, for and in consideration of the sum of One dollar & other valuable considerations Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said party of the second part the following described real estate and premises situated in Creek Nation, and within the limits of the Indian Territory to-wit:

all his undivided interest in the allotment of his deceased brother Prath Childers, said allotment being the Northeast quarter of Section Three (3) Township Sixteen (16) North, Range Fourteen (14) East.

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Mildred Childers, wife of the said Daniel Childers, for and in consideration of the said sum of money do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said party of the second part his heirs, executors, administrators and assigns forever.
