

GENERAL WARRANTY DEED.

This Indenture, Made and entered into this 8th day of September, one thousand nine hundred and six, by and between A. L. Little and L. M. Little his wife of Cowley County, Kansas, part of of the first part, and W. H. Thompson of Sumner County, Kansas part of the second part,

WITNESSETH: That the said party of the first part, for and in consideration of the sum of Twenty five Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part of the second part the following described real estate and premises situated in the Sevier Nation, and within the limits of the Indian Territory to-wit:

Lot, Twenty seven in Block, Seventeen, in the town of Valley

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, A. L. Little, wife of the said A. L. Little, for and in consideration of the said sum of money do hereby re-

lease and relinquish unto the said party of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said party of the second part his heirs, executors, administrators and assigns forever.
