GENERAL WARRANTY DEED.

This Indenture, Made and entered into this 8th day of September, one thousand nine hundred and six, by and between A. L. Little and L. M. Little his wife of Cowley County, Kansas, part of the first part, and W. J. Pappewell of Sumner County, Kansas party of the second part,

WITNESSETH: That the said party of the first part, for and in consideration of the sum of Twenty five Dollars, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said party of the second part the following described real estate and premises situated in the Seventh Nation, and within the limits of the Indian Territory to-wit: Lot Twenty in Block Thirty-two, in the town of Valley

together with all the improvements thereon and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, A. L. Little, wife of the said A. L. Little, for and in consideration of the said sum of money do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said party of the second part, his heirs, executors, administrators and assigns forever.
