GENERAL WARRANTY DEED.

This Indenture, Made and entered into this 29th day of December, one thousand nine hundred and six, by and between Robert Nero, a single man and Chas. N. Runyan of Muskogee, I. T., part of the first part, and

WITNESSETH: That the said party of the first part, for and in consideration of the sum of Eighteen Hundred Dollars, in hand paid, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell, convey and confirm unto said party of the second part the following described real estate and premises situated in Creek Nation, and within the limits of the Indian Territory to-wit:

The North half of the South West quarter and the North West quarter of South East quarter of section thirty four, Township eighteen North, Range thirteen East, containing 120 acres, the same being the allotment of the grantor, Robert Nero.

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I,

Chas. N. Runyan, wife the said Robert Nero, for and in consideration of the said sum of money do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to the said lands.

To have and to hold the said lands unto the said party of the second part his heirs, executors, administrators and assigns forever.
