AGREEMENT.

THIS AGREEMENT, Made and entered into this 12th, day of April, A. D. 1909, by and between the Success Oil & Gas: Company, a corporation, represented and acting by and through John R. Shaw, its duly elected and acting President, and Franklin Miller, its duly elected and acting Secretary, as party of the first part, and H. C. Tyrrell, party of the second part.

WITNESSETH, THAT WHEREAS, heretofore and during the year 1907, there was pending in the Supreme Court of the State of wansas an action, wherein the Success Oil & Gas Company and Andrew Sewell were plaintiffs, and the Creek Oil Co., was defendant; and
