#38 Collinsville extension 12" Tank Line.

FOR AND IN CONSIDERATION OF SIXTY DOLLARS, to him in hand paid, receipt of which is hereby acknowledged Joseph P. Harter and Mary O. Harter, do hereby grant to the Oklahoma Natural Gas Company, a corporation, its successors and assigns, the right of way to lay, maintain, operate, relay and remove pipe lines for the transportation of gas, and erect, maintain, operate and remove telegraph or telephone lines if the same shall be found necessary on/ ober and through certain lands situate in Tulsa County, State of Oklahoma, described as follows:

Lot 2, Lot 7, Lot 8 & n $\frac{1}{2}$  of NW  $\frac{1}{4}$  of Sec 17, Twp. 19, Range 13 East, with ingress and egress to and from the same. The said grantors, heirs or assigns to fully use and enjoy the said premises, except for the purposes hereinbefore granted to the said Oklahoma Natural Gas Company, and it is hereby further agreed that the above payment is in full of all damages for the constructing, maintaining, relaying and removing the said pipe lines. And the said Oklahoma Natural Gas Company, its successors or assigns, may at any time lay an additional line of pipe alongside of the first pipe line as herein provided, upon the payment of a like consideration and subject to the same conditions
