## RIGHT OF WAY.

FOR AND IN CONSIDERATION OF THIRTY-THREE &amp; 25/100

Dollars to her in hand paid, receipt of which is hereby acknowledged Clarissa Bell, mother of John W. Perryman, a minor, do hereby grant to Oklahoma Natural Gas Company, a corporation, its successors and assigns, the right of way to lay, maintain, operate, relay and remove a pipe line for the transportation of gas, on, over and through certain lands situate in Tulsa County, Territory of Oklahoma, described as follows:

A strip of ground one rod wide and One hundred thirty three rods long through the South East Quarter (1/4) of Section Eight (8), Township Nineteen (19) North, Range Thirteen (13) East as more particularly appears in blue print of grantee, with ingress and egress to and from the same.

The said grantor, heirs or assigns to fully use and enjoy the said premises, except for the purposes hereinbefore granted to the said Oklahoma Natural Gas Company, which hereby agrees to pay any damages which may arise to crops and fences, from the laying, maintaining and operating said pipe lines; said damages if not mutually agreed upon to be ascertained and determined by three disinterested persons, one thereof to be appointed by the said grantor, heirs or assigns, one by the Oklahoma Natural Gas Company, its successors or assigns, and the third by the two so appointed as aforesaid, and the award of such three persons shall be final and conclusive.
