RIGHT OF WAY.

#43 Collinsville Extension 12" Line.

FOR AND IN CONSIDERATION OF FIVE & 20/100 Dollars, to them in hand paid, receipt of which is hereby acknowledged Tulsa Investment Co., Tulsa, Okla., do hereby grant to Oklahoma Natural Gas Company, a corporation, its successors or assigns, the right of way to lay, maintain, operate and relay and remove pipe lines, for the transportation of gas, through certain lands situate in Tulsa County, State of Oklahoma, described as follows:

NW. 1/4 of NE. 1/4 of Sec. 9, Twp 19 N. Range 13 E (South 30 acres) with ingress and egress to and from the same.

The said grantor, heirs or assigns to fully use and enjoy the said premises, except for the purposes hereinbefore granted to the Oklahoma Natural Gas Company, which hereby agrees to pay any damages which may arise to crops and fences, or any other improvements, from the laying, maintaining, and operating said pipe lines; said damages if not mutually agreed upon to be ascertained and determined by three disinterested persons, one thereof to be appointed by the said grantor, heirs or assigns, one by the Oklahoma Natural Gas Company, its successors or assigns, and the third by the two so appointed, and the award of such three persons shall be final and conclusive.

And it is hereby further agreed that the said Oklahoma Natural Gas Company, its successors and assigns, may at any time lay an additional line of pipe alongside of the first line as herein provided, upon the payment of a like consideration, and subject to the same conditions.
