Younkman, of Tulsa, Oklahoma, do hereby grant to Galbreath Gas Company, a corporation, its successors and assigns, the right of way to lay, maintain, operate, relay and remove pipe lines for the transportation of gas, and erect, maintain, operate and remove if the same shall be found necessary, on over and through certain lands situate in ----- County, State of Oklahoma, described as follows:

E $\frac{1}{2}$ of NE4 of Sec. 32, Twp. 19, Range 13 East and the W $\frac{1}{2}$ of the NE4 and SE4 of the NE4 of Sec. 33, Twp. 19 Range 12 East, with ingress and egress to and from the same.

The grantor, heirs or assigns to fully use and enjoy the said premises, except for the purposes hereinbefore granted to the said Galbreath Gas Company, and it is hereby further agreed that the above payment is in full of all damages for the constructing, maintaining, operating and removing the said pipe lines.
