FOR AND IN CONSIDERATION OF NINE AND no/100 Dollars, to her in hand paid, receipt of which is hereby acknowledged Rachel Simmons, nee Wilnson, Claremore, Okla., does hereby grant to the Oklahoma Natural Gas Company, a corporation, its successors and assigns, the right of way to lay, maintain, operate, relay and remove pipe lines for the transportation of gas, and erect, maintain, operate and remove telegraph or telephone lines if the same shall be found necessary on, over and through certain lands situate in Tulsa County of Oklahoma, described as follows:

South  $\frac{1}{2}$  of North West  $\frac{1}{4}$  Sec. 18, Township 21 N., Range 14 E. with ingress and egress to and from the same.
