RIGHT-OF-WAY.

The said grantor heirs or assigns to fully use andenjoy the said premises, except for the purposes hereinbefore granted to the said **p**kfahoma Natural Gas Company, which hereby agrees to pay any damages which may arise to crops and fences from the laying, maintaining and operating said pipe lines; said damages if not mutually agreed upon, to be ascertained and determined by theree disinterested persons, one thereof to be appointed by the said grantor, heirs or assigns, one by the Oklahoma Natural Gas Company, its successors or assigns, and the third by the two so appointed and the award of such three persons shall be final and conclusive.

And it is hereby further agreed that the said Oklahoma Natural Gas Company, its successors and assigns, may at any time lay an additional line of pipe along side of the first line as herein provided, upon the payment of a like consideration and subject to the same conditions.
