Drew and Emma Drew, his wife, do hereby grant to Oklahoma Natural Gas Company, a corporation, its successors and assigns, the right of way to lay, maintain, operate, relay and remove pipe lines for the transportation of gas and erect, maintain and operate telegraph or telephone lines if the same shall be found necessary, on, over and through certain lands situate in Tulsa County, State of Oklahoma, described as follows:

The North One Half of the North East Quarter of Section 19, Township 19 North of Range 13 East, with ingress and egreess to and from the same.

The said grantor, heirs or assigns to fully use and enjoy the said premises, except for the purposes hereinbefore granted to the said Oklahoma Natural Gas Company, which hereby agrees to pay any damages which may arise to crops and fences from the laying, maintaining and operating said pipe lines; said damages if not mutually agreed upon, to be ascertained and determined by three disinterested persons, one thereof, to be appointed by the said grantor, heirs or assigsn, one by the Oklahoma Natural Gas Company, its successors or assigns, and the third by the two so appointed as aforesaid, and the award of such three persons shall be final and conclusive.

And it is hereby further agreed that the said Oklahoma Natural gas Company, its successors and assigns, may at any time lay an additional line of pipe along side of the first line as herein provided, upon the payment of a like consideration and subject to the same conditions.
