A g r e e m e n t

THIS AGREEMENT, made and entered into this 23rd, day of September 1909, by and between L. C. Conroy, party of the first part, and D. D. White, party of the second part

WITNESSETH: That party of the first part, in consideration of the sum of One Dollar (\$1.00) and other sums of money and othr good and valuable considerations to him in hand paid by the party of the second part, receipt of which is hereby acknowledged, does hereby transfer, assign and set over to the party of the second part, all his right title claim and interest in and to the following described oil and gas mining leases, to-wit:
