The undersigned commissioners were and are disinterested free hold rs of Tulsa C unty Oklahoma, and reside outside of the limits of said School District, and not interested in any like question, and nn the the 22nd day of May A. D. 1909, did appear before Thos.

W. Walker, a Notary Public, in and for said County, Oklahoma, and tsubscribe to the cath prescribed by law, and thereupon proceeded to inspect the real proprty described as follows, to-wit:
