petitioners being present in person and represented by their attorney, Haskell B. Talley, and the Court having examined all the proceedings had herein and having heard the testimony of said Martha Litka and Tyler Burgess and the testimony of appraisers, and_____, two disinterested Witnesses, and having heard argument of petitioner's counsel, Haskell B. Talley, finds:

That Gussie Burgess was a full-blood allottee of the Creek Nation, and that her allotment embraced among other property the following described lands:

S1 SW1 Section 27, Township 18 N., Range 14 E.

DCNF

The said Gussie Burgess died on or about the 8th, day of September 1908, intestate, unmarried and without issue, leaving surviving him as his sole and only heirs at law, his brother, Tyler Burgess and his sister Martha Litka, and that the fee in said estate vested at the death of said allottee in Tyler Burgess and Martha Litka.

 $T^{\mu}e$ C'urt further finds that on the 6th, day of July 1909, the said Tyler Burgess . and Martha Litka, Granted, bargained, sold and conveyed to T. A. Duey, his heirs and grantees forever, all their right, title and interest in and to their estate in said premises; that said T. A. Duey, gave as a consideration for the grant un der said deed, the sum of Thirty Four Hundred Dollars (#3400.00), and that said sum has been paid according to the terms f said deed to said Tyler Burgess and wartha Litka by T. A. Duey, and that the reasonable value of the said estate is Thirty Four Hundred Dollars (\$3400.00) and that all proceedings had herein are regular and according to law.

Wherefore premises considered, the Court approved the deed made by Tyler Burgess and Martha Litka on July 6th 1909, to T. A. Duey, for the said described part of the allotment of their brother Gussie Burgess, and confirms and vests the title to said premises in the said T. A. Duey, forever, as provided under Section Nine of the Act of Congress, approved May 27, 1908 (Public No. 140).
