bid, that said sale was legally made and fairily conducted; that said sum is not disproportionat to the value of the property sold and that a sum exceeding such bid at least ten per cent exclusive of the expense of a new sale cannot be obtained, and that said F. S. Kent as such guardian in all thing proceeded, conducted and managed such sale as required by statute in such cases made and provided and as by said order of slae required and directed.

It is therefore ordered, adjudged and decreed that the said sale be and the same is hereby confirmed and approved and declared valid, and the said F. S.
