ORIGINAL CONTRACT AND AGREEMENT.

THIS CONTRACT AND AGREEMENT, made and entered into this 26th, day of June 1909, by and between the Margaret Oil Company, a corporation, of Tulsa, Oklahoma, party of the first part, and the Central Light and Fuel Company, a corporation of Sapulpa, Oklahoma, party of the second part.
