The party of the second part hereby reserves unto itself and excepts from this contract sufficient gas for such drilling and developing and operating the same for oil and gas mining purposes.

This contract shall be binging and in full force and effect against the heirs and assigns of the party of the first part and the successors and assigns of the party of the secondpart.
