amount of gas than One Million (1,000,000) cubic feet daily, all gas furnished to and used by the party of thesecond part in excess thereof shalf be paid for by the party of the second part at the regular prevaling market price in the Glenn Pool for gas at the time the same is furnished and consumed:

It is further understood and agreed by and between theparties hereto that the party of the second part shall have the first call on said gas up to 1,000,000 cubic feet daily and no gas produced on saidland except from the excess of the de-serve requirements hereunder shall be sold therefrom until the party of the second part, and its subsidary and affiliated companies, have received therefrom the amount of gas to be provided by them under the terms of this contract, and, if said land does not produce an amount of gas more than sufficient to enable the party of the first part to comply with the terms and conditions of this lease, then in that event, the party of the second part its subsidary and affiliated companies shall have the entire output of gas produced or to be produced on or from said above described lands, the same to be paid for as hereinhoffore provided.

It is further understood and agreed on by and between the parties hereto that the party of the first part shall have the rightto sell gas produced on said above described lands to such other persons who may be desirous of purchasing the same, so long as the sale of said gas does not interfere with the party of the second part, its subsidiary and affiliated companies procuring and amount of gas sufficient for their use and purposes, up to 1,000,000 cubic feet per day and shall have the right, at its own cost and expense to tap the pipe line put down by the party of the second part, and make connections there with at any point thereon, but said right to sell and dispose of said gas depends wholly upon the fact that said party of the first part, shall have in reserve three times the amount of gas required to meet the needs and requirements of the party of the second part, its subsidiry and affiliated companies, as above provided:

It is hereby further understood and agreed by and between the parties hereto that t the party of the secred part agrees to purchase and take off and from the party of the first part all the gas used by it and its subsidiry companies in the Glenn Enol, and pumping stations in connection therewith, so long as gas shall be produced in paying qunati ties from said above described lands, and to pay for the same at ther ate hereinbefore pro vided, and not to take purchase or procure of any other person gas for such purposes so long as gas is produced in paying quantities from said above described lands.

It is further understood and agreed on by and between the parties hereto that the party of the first part shall pay all royalties, and comply with all rules and regulations that are now, or may hereafter be put in force by the Interior Departement, and with the terms and conditions of all leases on said above described lan s, which are under the control of the departement of the Interior, and if said party of the first part shall fail or neglect to pay such royalties, and comply with such rules, then, in that event, the party of the secondpart is hereby authorized to do the same, at the expense of the _ ... party of the first part.

It is further understood and agreed that the party of the second part shallmake a settlement on or before the loth, day of each month for all gas used by it for the preceeding month according that we meter measurement thereof as hereinhefore set forth.

It is further understood and agreed on by and between the parties hereto that the party of the second part in putting down of said four inch (4") gas pipe from said Watkins station to said well number _____ and in mixing connections therewith, shall, in all things comply with the rules and regulations of the Interior Departement, governing the same, and if the said party shall sink and put down wells on said above described lands when the
