TO HAVE AND TO HOLD said described premises unto the saidparty of the secondpart, her heirs and assigns, forever free, clear, and discharged of and from all former grants, charges, taxes, judgements, mortgages and other liens and encumbrances of whatsoever nature.

ORDER FOR REMOVAL OF RESTRICTIONS.

DEPARTEMENT OF THE INTERIOR WASHINGTON, D. C., AUG. 31, 1909.

HGH Number 3815 Roll Number 1929 1/2 Block.

WHEREAS, Eliza H. Allen, an allottee of the Creek Nation, has made application for the removal of restrictions from the following described land, to-wit:

South East Quarter (SE4) of South West Quarter (SW4) of Section Thirty Three (33) Township Seventeen (17) North, Range Thirteen (13) East of the Indian Base and Meridian containing 40 acres, more or less.

NOW, THEREFORE, I, under the authority vested in me by the Act of Congress approved May 27, 1908 (Public No. 140) and the regulations prescribed thereunder, hereby remove the restrictions from said above described land without conditions concerning terms of sale and disposal of the proceeds; said removal of restrictions to be effective thirty days from date hereof.
