WAIVER OF OBLIGATION UNDER BOND.

KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, on the 10th, day of December 1908, the Secretary of the Interior approved an oil and gas mining lease on the allotment of Susan Sanders, nee Cook, said allotment embracing:

Said lease being made by Susan Sanders, nee Cook, to the Duquesne Oil and Gas Company, a corporation, and
