OIL AND GAS LEASE.

THIS AGREEMENT, Made and entered into, in triplicate, on this 15th, day of October A. D. 1909, by and between Samuel J. Checote, as guardian of the estate of Martha Perryman, a minor of Okmulgee, Oklahoma, party of the first part, and Bessie L. Turman/ of Okmulgee, Okla., party of the second part.

WITNESSETH: That the said party of the first part for and in consideration of the sum of Two Hundred Dollars (\$200.00) cash bonus, in hand paid, the receipt whereof is hereby acknowledged, and the royalties, covenants, stipulations and conditions hereinafter contained, and hereby agreed to be paid observed and performed, by the party of the second part, her heirs, successors and assigns, does hereby demise, grant and let unto the party of the second part, her heirs, successors and assigns, for a term ending August 1, 1916, (not however beyond the majority of the said minor) all of the oil deposits and natural gas in and under the following described tract of land, and also the said tract of land for the purpose and with the exclusive right of operating thereon for oil and gas, together with the right of way over said premises, the exclusive right to lay pipe line over and upon the same, to erect and maintain thereon all machinery, buildings, power tanks, fixtures, and telephone and telegraph lines necessary or required in operating for oil and gas, which tract of land is situated within the County of
