RELEASE OF MORTGAGE.

KNOW ALL MEN BY THESE PRESENTS:-

That we, the undersigned, Clifton C. Drew, and Emma Drew, of Tulsa, Oklahoma, mortgagees of a certain mortgage made September 1st, 1908, by Marion J. Tilton and Della Tilton, his wife of Tulsa, as mortgagors, to secure the payment of a promissory note, payable to the order of said Clifton C.
