

A S S I G N M E N T.

THIS AGREEMENT, Made and entered in to this the 1st, day of June A. D. 1909, by and between Samuel Rabinovitz, hereinafter designated as first party, and Isaac Rabinovitz, hereinafter designated as second party, both of Marietta, Ohio.

WITNESSETH: That the said first party for and in consideration of the sum of One Dollar (\$1.00) to him well and truly paid by the said second party the receipt in payment of which is hereby acknowledged, does hereby grant, bargain, sell assign transfer and set over unto the said second party, his heirs and assigns, the undivided One Half ^{working} interest in and to that certain leasehold estate for oil and gas purposes, made and executed by George W. Adams to P. J. White, Thomas White and W. G. Lewis, in the fall of the year 1908, leasing the said George W. Adams farm,

Which is the North East Quarter of the South West Quarter of North East Quarter of Section 24, in Town 20, Range 12 East, in Tulsa County, State of Oklahoma which lease is duly recorded in the office of the recorder of Tulsa County, at Tulsa Oklahoma, to which reference is hereby made for a full description of said lease

Together with a like interest in three (3) producing oil wells situate upon said lease, which three wells are now producing about Two Hundred (200) barrels of oil per day, as well as the machinery, tanks, tubing, casing, tools and fixtures, appliances and appurtenances now situate thereon and thereunto belonging; and also a like interest in the oil produced from the premises on and after said date.

TO HAVE AND TO HOLD THE ABOVE DESCRIBED LEASEHOLD interest and the property hereby conveyed unto the said second party, his heirs and assigns, subject nevertheless, to all the terms and conditions contained in the lease hereinbefore referred to, reference to said original lease being had where such terms and conditions will fully and at large appear.
